



## **Purdue Global Law School Veterans' Scholarship Award**

The Veterans Scholarship Award is designed to acknowledge the efforts of students who are currently enrolled in the JD or EJD program and currently work or plan to work with the military veterans' community. Four Scholarships will be applied in the form of a \$1,250 tuition credit in the academic term following recipients' acceptance.

### **ELIGIBILITY REQUIREMENTS**

- Must be in good standing in the JD or EJD program at Purdue Global Law School.
- Must have been enrolled in at least 5 credits per term in the prior academic year.
- Must submit a resume and essay by February 28, 2025.
- Must submit a current resume.
- Must complete an essay (maximum 750 words) answering the following:
  1. In what ways do you currently work or engage with military veterans? If you are not currently working with veterans, in what ways do you intend to work with or support the veterans' community?
  2. How do you envision using your legal education to make a positive impact on the veterans' community?
  3. How will this scholarship help to further your service to the veterans' community?

Submissions will be reviewed based on the following rubric: relevance to prompt, 10-20 points; depth of reflection, 10-20 points; specificity/provides examples, 5-15 points; structure and organization, 15-25 points; writing and mechanics, 10-20 points. The full rubric can be viewed [here](#).

Submissions must include the student's full name, program, and student ID number and must be the original work of the student. Submissions that do not meet these criteria will be disqualified and not considered.

### **ADDITIONAL TERMS AND CONDITIONS**

- Winners will be notified via email.
- Awardees must enroll in and complete the next term of their academic program.
- Selection of recipients is made by Purdue Global Law School. All applicants agree to accept the decision of Purdue Global Law as final.

## OTHER TERMS AND CONDITIONS

- A student can only receive the Scholarship once during their lifetime enrollment at Purdue Global Law School.
- If it is later discovered that any information contained in a Scholarship awardee's resume or essay was materially inaccurate, incomplete, or fraudulent, Purdue Global Law School reserves the right to rescind the Scholarship.
- Awards are limited to one per student and are not transferable.
- There is no direct cash benefit provided. The Scholarship will be provided as a credit on recipients' Purdue Global Law School student ledger.
